#### Illinois Veterans Advisory Council Elects New Leadership

The Illinois Veterans Advisory Council (IVAC) elected its new leadership following the completion of the twoyear terms of its former leadership Chairman Colonel Mike Peck, and Vice-Chair Jerry Field.

"We are grateful for the leadership of Chairman Peck and Vice-Chair Field," said Director Terry Prince, "Since I joined IDVA in April 2021, they have offered tremendous support and provided insight and ideas for how we can continue to serve Veterans across our state."

Chairman Keith Wetherell of Springfield was elected to his two-year term at the December IVAC meeting. After graduating from Springfield Sacred Heart-Griffin in 1995, Keith joined the United States Marine Corps where he served until 2003, four years active duty and four years reserve. After returning from active duty in 1999, he worked at the Illinois Veterans Leadership Program (IVLP), the beginning of a long career in serving Veterans, their families, and communities. In 2002, he joined Illinois Amvets where he currently holds the position of Executive Director. Mr. Wetherell serves on many committees and boards including Governor Pritzker's Hero's Transition Team (2018), Illinois Veterans' Advisory Council (delegate from 2008 to present), Illinois Amvets Service Foundation (2015-present), Illinois Department of Veterans Affairs State Fair Committee (2014-present), Illinois Veterans' Memorial Commission (delegate from 2011 to 2012), and the Illinois Department of and Veterans' Affairs Lottery Grant Committee (delegate 2006 to 2007). Mr. Wetherell earned his bachelor's degree in Business Administration from the University of Illinois Springfield and his master's degree in Business Administration from Western Illinois University. Mr. Wetherell was named non-for-profit Executive Director of the year by the Springfield Chamber of Commerce in 2017. He resides in Springfield with his wife Dana and two sons Charles and Tyler.

Newly elected Vice-Chairman Bob Tyler served on active duty in the Marine Corps for over 30 years. He was a helicopter pilot in Vietnam and later commanded a KC-130 squadron. Following a tour as Director of Aviation Safety at Headquarters Marine Corps, he earned a doctorate in Applied Psychology. That afforded him the opportunity to be on teams supporting the Federal Aviation Administration, Department of Homeland Security, Department of Defense and the United States Navy. Since returning to central Illinois in his second retirement, Dr. Tyler has become involved in Veteran advocacy and has for the past several years been the president of the Illinois Military Officers Association of America (MOAA) Council of Chapters. He hopes his service with the IVAC provides continued opportunities to bring Veterans' issues to Illinois legislators in a forum conducive to constructive resolutions.

The Illinois Veterans' Advisory Council under 20 ILCS 2805/15, was established by Public Act 93-0779 on July 21, 2004. It meets quarterly or at the call of the Chairman, Director of Veterans' Affairs or the Governor. The Council is empowered to:

- Advise IDVA with respect to the fulfillment of its statutory duties.
- Review and study the issues and concerns that are most significant to Illinois Veterans and advise the Department on those issues and concerns.
- Receive a report from the IDVA Director or the Director's designee at each meeting with respect to the general activities of the Department.
- Reports to the Governor and the General Assembly annually describing the issues addressed and the actions taken by the council during the year, as well as any recommendations for future action.


#### Myron Kirby: An Illinois Hero

This past year, Illinois lost a hero who dedicated his life to advocating for Veterans, Myron Dean Kirby. An Illinois National Guard Veteran, Myron served as the Chairman of the Illinois Veterans Advisory Council (IVAC) from 2019-2021 where he championed integral legislation in the interest of Veterans across Illinois, including the Medal of Honor Highway designation. He graciously co-hosted the IDVA staff retreat where he shared the history of the "Red Poppy." He also served on the State Fair Committee ensuring that Veterans and Gold Star Families Day was a memorable day for Veterans and their families. His other work in the Veteran community included Commander of the Legion Post 55; 19th District Commander, 4th Division Commander, Department Commander, Department Treasurer, National Finance Vice Chairman, Past Chef DeBare of Voyager 238 of 40/8; and member of Farmer City Masonic Lodge #710 A.F. & A.M.

"Myron was dedicated to Veterans in Illinois and a strong supporter of IDVA," said Crystal Womack, IDVA, Senior Program Policy Advisor, "We are grateful for having had the opportunity to work alongside him in improving the lives of Veterans in Illinois."

Myron was a farmer, owner of a tile and excavating company, and Kirby Trucking. He was actively involved in the local business community as the DeWitt County Soil Chairman of the Board and State President of the Illinois Soil and Water Conservation Districts. He was also a member of the National Child Welfare Foundation.

Myron was born on September 29th, 1950 in Bloomington, Illinois and passed away on October 30th, 2022 in Farmer City, Illinois.



#### **Student Veteran Of The Year**

Loyola University Chicago senior Josh Jones has been named Student Veteran of the Year by <u>Student Veterans of America (SVA)</u> – a nonprofit organization that seeks to elevate the academic, professional, and personal development of veterans in higher education through a network of on-campus chapters in all 50 states and three countries overseas.

Jones, an economics major with a minor in biology in Loyola's College of Arts and Sciences, was named president of Loyola's SVA chapter in 2021. He is a Marine Corps Veteran who served as a 2311 Ammunition Technician stationed in Camp Lejeune, North Carolina with units such as 2nd Battalion 6th Marine Regiment and 2nd Marine Logistics Group. His accomplishments both in and out of uniform recently received personal recognition from Representative Michael Bost, chairman of the U.S. House of Representatives Committee on Veterans' Affairs.

"I am extremely honored and humbled to receive the 'Student Veteran of the Year' award from SVA," said Jones. "This organization is deeply passionate about supporting veterans and has provided me with so many opportunities. SVA is essential to the success of student veterans – I hope to continue working with the network for a long time."

## **News from the Capitol**

The beginning of the 103rd General Assembly is off to a strong start. At the time of this update 3,978 House Bills have been filed and 2,530 Senate Bills have been filed. Currently, IDVA is tracking over 100 bills. Some affect veterans and their families, some affect active duty service members, others affect state agencies with 24/7 facilities and others affect nursing homes. Bills become law, and it is important to track and monitor legislation to make sure IDVA is compliant in all areas.

However, of equal importance during the spring legislative session is the FY 24 budget process. On Wednesday February 15th, Governor J.B. Pritzker delivered a combined State of the State and budget address.

IDVA's FY23 enacted budget was \$183.4 million. IDVA's FY24 recommended budget in the Governor's introduced budget is \$213.3 million. This is not the final budget. IDVA will present the FY24 budget to the House and Senate in several weeks. IDVA will make the case for an increased budget to support Illinois Veterans and their families.

This budget includes increases for existing line items and new requests. These include but are not limited to:

- Additional funds for the Illinois Veterans' Home at Chicago to continue to welcome new residents.
- Funding for increased security and safety enhancements at the five veterans' homes.
- Increases across the board to continue to provide

#### Attorney General Raoul Releases Updated Guidance On Veteran's Legal Rights

Attorney General Kwame Raoul issued an updated guidance for Illinois service members to ensure the legal rights of Illinois veterans, service members and their families are upheld and easily accessible. Raoul's updated "Legal Rights of Illinois Service Members" guide also includes federal and state veteran benefit laws.

Attorney General Raoul's "Legal Rights of Illinois Service Members" guide details new and updated laws that benefit veterans, including:

- Uniform Services Employment and Reemployment Rights Act (USERRA): Federal service member employment rights law that outlines rights for the employed member and obligations of the employer.
- Illinois Service member Employment and Reemployment Rights Act (ISERRA): Law that outlines state service member employment rights.
- Service Members Civil Relief Act (SCRA): Active service members can no longer lose custody of a child based solely on deployments, and courts will no longer consider deployments when determining custody.
- Illinois Service Member Civil Relief Act (ISCRA): Law enacted to supplement the SCRA. It strengthens existing consumer protections, and provides addition-

al protections for active-duty service members, reservists, members of the Illinois National Guard and their spouses during their periods of military service.

- Homestead Exemption for Veterans with
   Disabilities: Qualified veterans or surviving spouses may be eligible for a reduction in property taxes based on the equalized assessed value of the primary residence.
- **Returning Veterans Homestead Exemption**: For the 2007 taxable year and thereafter, a homestead exemption is provided to eligible returning veterans. The exemption is a one-time \$5,000 reduction in the equalized assessed value of the veteran's primary residence.
- Free credit freeze for Active-Duty Service
   Members: Illinois' Consumer Fraud and Deceptive
   Business Practices Act entitles active duty service
   members to a free credit freeze if they become
   victims of identity theft.
