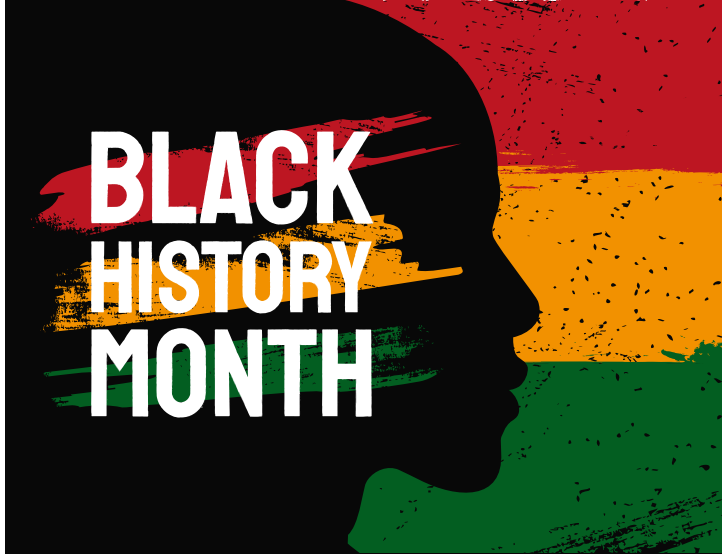

Monthly Highlights



Black History Month

February is Black History Month where we celebrate the achievements of Black Americans and recognize their central role in the history of our nation.

In his proclamation dedicating February 2022 as Black History Month, President Joe Biden said, "Each February, National Black History Month serves as both a celebration and a powerful reminder that Black history is American history, Black culture is American culture, and Black stories are essential to the ongoing story of America — our faults, our struggles, our progress, and our aspirations. Shining a light on Black history today is as important to understanding ourselves and growing stronger as a Nation as it has ever been".

Throughout the month, IDVA has featured many of our African American Veteran heroes on social media. Since the Revolutionary War, Black Americans have served and fought for freedoms – in many cases, the very freedoms which were not immediately granted to them. We are grateful for their service and honor them not just this month but throughout the year.

February 18: National Caregivers Day

National Caregivers Day is recognized on Friday, February 18, 2022. Illinois Department of Veterans' Affairs employees hundreds of caregivers in its five Veterans' Homes. The healthcare professionals provide vital services to our veterans 24/7 and deliver a variety of duties including personal and medical care. The model is holistic and cares for the whole person by creating a vibrant community with a team of dedicated professionals. We are grateful for the compassion, professionalism, and commitment to bettering the days of the veterans entrusted in the care of Illinois' veterans' homes.

February 28: Desert Storm Remembrance Day

Monday, February 28, 2022, marks the 31st anniversary of the end of Operation Desert Storm. The Remembrance Day program will be held virtually with remarks offered by Governor JB Pritzker and IDVA Acting Director Terry Prince to honor those who served. Illinois was a big part of Desert Storm with ten Army, eight Navy and five Air National Guard and Reserve units from Springfield, Peoria, Chicago, Scott Air Force Base, Rock Falls, and Fort Sheridan deployed to the conflict.

695,000 U.S. service members deployed during the war and for 42 days and nights, our military, along with 38 partner nations, fought to end Iraq's seven-month occupation of Kuwait. The air campaign was the most intense in military history, utilizing state-of-the-art artillery and the 100-hour ground campaign was equally as intense. The result was a rapid and resounding victory.

While the mission was successful, nearly 400 service men and women gave their lives, including 18 Illinoisans. They made the ultimate sacrifice. Operation Desert Storm Remembrance Day is a time to pause and remember those we lost and honor those who served.

Education Looks Different for Everyone

The IDVA Veterans Education and Training Section (VETS) team is poised to help veterans and their families obtain earned education and training benefits. The opportunities are vast including college degree and certificate programs, on-the-job training, apprenticeships, flight training, and correspondence courses.

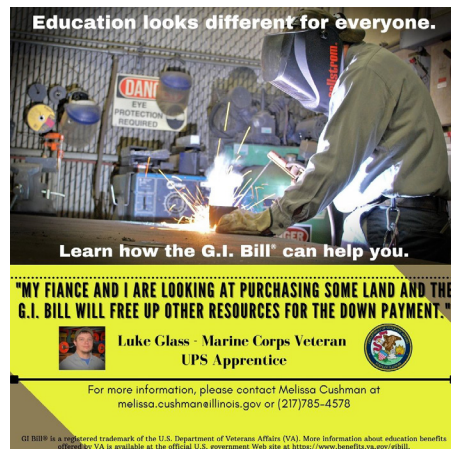
In this issue, we are highlighting the G.I. Bill™ and real-life stories of how Illinois veterans have redirected their lives by participating in the G.I. Bill program.

Meet Victor Fulgencio, a United States Marine Corps Veteran

who is completing his second year of a five-year apprenticeship to become a journeyman pipefitter through the Pipefitters Local 597 in Mokena, Illinois. Victor, a Motor Transport operator in the Marine Corps, attributes his training and experience as a Marine with preparing him for the apprenticeship program.

"The program is challenging. We have welding deadlines and classroom work where we learn about pipefitting," said Victor. He added, "the G.I. Bill and Housing Allowance helped me get started."

Meet Marine Corps Veteran Luke Glass who directed his G.I. Bill toward training as a maintenance mechanic with UPS. Luke trains at the Chicago-area consolidated hub, which averages 1.8 million packages a day through its facility and up to three million during the holidays. Luke's primary responsibility is to maintain the equipment that moves packages through the facility. The 48-month apprenticeship program requires both classroom and on-the-job training.



"As a maintenance mechanic, I make sure the building continues to run and gets packages out of the building to trailers in a timely manner," said Luke.

Luke attributes the G.I. Bill program with helping him successfully transition from the Marine Corps to a solid civilian career.

Meet Bill Henry, a United States Army Veteran, who is finishing his second year of a five-year apprenticeship program through the Pipefitters Local 597 in Mokena, Illinois. A wheeled-vehicle mechanic in the Army, Bill attributes the G.I. Bill to helping him apply his background to a solid civilian career.

"By the time you leave the program, you will be confident in what you are doing," said Bill. "The G.I.

Bill covered my early expenses, so I could save and build a nest-egg while working."

Introducing IDVA University

IDVA Field Services introduces IDVA University (IDVA U), a new Veterans Service Officer Training Platform. This training is the standard for state title certification and accreditation through the United States Department of Veterans Affairs. The 12-module training program modeled around the federal VAs Training Responsibility, Involvement, and Preparation (TRIP) training program will be required by all VSOs. Each module is designed to equip VSOs with the tools, resources, and knowledge to better navigate the benefit process with veterans. The IDVA U modules are an opportunity to gain integral information for being a successful VSO. It also brings together VSOs with many years of experience and lessons learned. It is a space to collaborate, share ideas, and build relationships. Once all modules are complete and the final exam passed, a VA Form 21a will be sent to the VAs Office of General Council for accreditation, better preparing IDVA Field Services to fulfill its mission of empowering veterans and their families to thrive.

Welcome Home: Veterans' Home at Chicago welcomes its first resident veterans

In a historic moment for Illinois' veterans, we welcomed the first two veterans into Illinois' fifth Veterans' Home, the Illinois Veterans' Home at Chicago. In 2008, (then) Director Tammy Duckworth first envisioned a new veteran's home in Illinois. At that time, there were over 2,000 people on the waiting lists. After many years of planning, construction, and delays, the home welcomed its first two residents on January 5th. The Chicago team is led by Administrator T'Kira Siler-Wilkerson who was instrumental in recruiting, hiring, and training staff as well as managing the final details of the home's construction and preparation for opening. The home offers space to 200 veterans and will employ up to 300 staff. While we couldn't celebrate with a large event to commemorate the day because of COVID precautions, the Chicago team welcomed them with open arms, balloons, music, and cheers. Congratulations to T'Kira Siler-Wilkerson and the entire IDVA team for a successful opening of the home. A special thanks to the staff from the four other homes who, in addition to their own jobs, provided much needed help in various departments.



An official Welcoming Event will be planned dependent upon the COVID-19 pandemic. To date, eight veterans reside in the home.

Welcome Brandi Melton: Veterans' Home at LaSalle Administrator



Brandi Melton, Administrator for the Veteran's Home at LaSalle, leads a team of 235 caring for up to 184 veterans. She joined IDVA in 2021 after serving as the administrator of the 103-bed Sunrise Skilled Nursing Home in Virden, IL. She has woven together experience in the public and private sectors,

all centered around care for seniors and substance abuse rehabilitation. Her private sector roles include activities coordinator in a long-term care home where she created a vibrant community for her residents to thrive. She was also the regional operations manager for a home health care network where she oversaw the programming and compliance of five regional branches. As part of Project Jefferson, a contract with the Department of Defense, she directed the Illinois Army

National Guard substance abuse and suicide prevention program and aided Commanders in engaging soldiers in substance rehabilitation.

"There is a great sense of professional satisfaction serving our nation's heroes. I love what I contribute to Veterans' lives and I enjoy having meaningful work that allows me to ensure our Veterans receive the highest standard quality of life, care, compassion, and commitment to the benefits they earned," said Brandi about her work.

She earned her Bachelor of Arts in Criminal Justice Studies from MacMurray College and her Master of Arts in Human Services and Social Service Administration, from the University of Illinois at Springfield, College of Human Services. She is currently working toward her Master of Arts in Public Health Administration at Benedictine University.



Thank you to Dawn Whitcomb, Adjutant at the Veterans' Home at Quincy

Dawn Whitcomb, United States Navy veteran, served at the Veterans' Home at Quincy for over 25 years. In each of her roles she has centered her energies around Quincy's veterans. She began her Quincy Home career as a Ward Clerk at Schapers Hospital as a student. She then enlisted in the Navy as a Hospital Corpsman where she served in Desert Shield/Storm and earned several military citations including the Fleet Marine Force Ribbon, Navy and Marine Corps Achievement Medal, Good Conduct Medal, Navy Unit Commendation, and the National Defense Service Medal.

Dawn returned to the Veterans' Home at Quincy as an activity therapist where she created a vibrant community for the resident veterans. She shifted roles to Reimbursement Officer with the Adjutant's Office where she was instrumental in resident admissions and for the last ten years, Dawn has served as the IVHQ Adjutant where she advocated for the home's veterans, spouses, and widows. She also supervised critical resident services and built lasting partnerships with local veteran organizations.

"Dawn's spirit and commitment to our veterans and community has contributed to the quality of care we

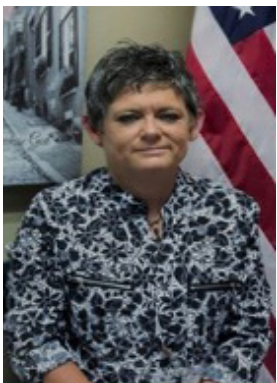

Angela joined IDVA in 2013 as the Nursing Home Administrator for the Veterans' Home at Anna before recently accepting the position of IDVA Senior Home Administrator, leading the team of administrators running Illinois' five nursing homes. Angie's list of achievements is noteworthy. In 2015, she won the Illinois "Pioneer-

ing Culture Change Champion of the Year" award and in 2020, was elected to the Illinois Nursing Home Administrator Board of Directors. Angie is dedicated to changing the culture of long-term care into more of a homelike "resident centered" environment. She has a history of excellence in education, presenting on

person-centered care, dementia care training and disaster preparedness. Recently, she was a guest lecturer to a statewide audience on best practices for nursing homes against Covid-19.

Angie's advice to her team, "leave yesterday's problems behind. Don't bring yesterday's problems with you today, because you just doubled your problems."

Angie was raised in Southern Illinois and is the proud daughter of a Vietnam veteran. She graduated from Nursing School at Shawnee Community College in 1997 and earned her bachelor's degree at Mid-Continent University. She is committed to service in the community and volunteers much of her personal time supporting the Special Olympics.

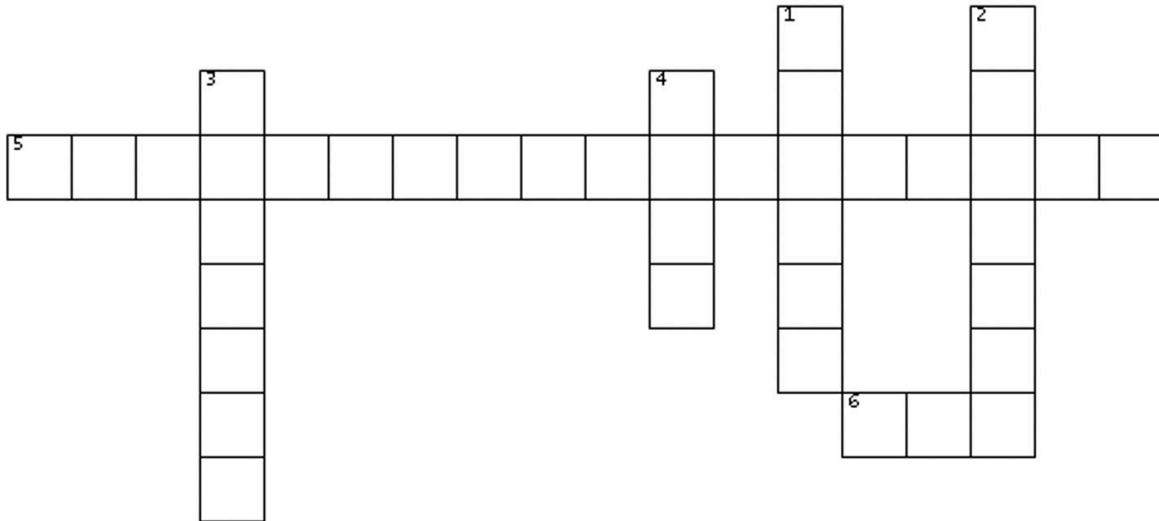
