To honor the passing of former First Lady Rosalynn Carter, I would like to recognize her important work for our largest group of employees, the caregivers. In the veteran space, caregiving is central to those who may have experienced significant illness or injury. At IDVA, we have five Veterans Homes providing caregiving services to our most vulnerable population, elderly veterans living in the Veterans' Homes. As part of her dedication to caregiving, Mrs. Carter established the Rosalynn Carter Center for Caregiving. She designed a program specifically for the military, Operation Family Caregiver (OFC). # **Capitol Corner**

## **Fall Veto Session**

The Illinois General Assembly's fall veto session was held October 24-26 and November 7-9. in Springfield, IL. <u>HB 2507</u>, the property tax omnibus bill that contained changes to the Homestead Exemption for Veterans with Disabilities, was vetoed in August. The veto was due to a property tax provision related to nursing homes. It was not the result of changes to the Homestead Exemption for Veterans with Disabilities. Despite this, the amendatory veto prevented the entire bill from becoming law. Therefore, HB 2507, the property tax omnibus bill containing changes to the Homestead Exemption for Veterans with Disabilities, needed to be addressed during the fall veto session.

Instead of addressing the amendatory veto directly, legislators decided to take most of the legislative language from HB 2507 and place it on an amendment to SB 2315. As a result, <u>SB 2315</u> became the new bill containing changes to the Homestead Exemption for Veterans with Disabilities. The veterans language in SB 2315 is identical to the veterans language that was in HB 2507, and the summary is as follows:

SB 2315 is the Property Tax Omnibus bill. SB 2315 makes four major changes to the Homestead Exemption for Veterans with Disabilities section of the Property Tax Code. First, it changes the name of the "Homestead Exemption for Veterans with Disabilities" to the "Homestead Exemption for Veterans with Disabilities and Veterans of WWII", creating a property tax exemption for all WWII veterans, regardless of their disability ratings. Second, it provides that for taxable year 2024 and thereafter, for veterans that are rated 70% or higher, "the first \$250,000 in equalized assessed value of the property is exempt from taxation", regardless of the value of the property. Previously, the overall value of the property was taken into consideration. Third, it provides that for taxable year 2024 and thereafter, the definition of "veteran" no longer requires an "honorable discharge." Rather, the veteran must have a service-connected disability for which the veteran receives disability compensation. Fourth, it specifies that the Act cannot be used as the basis for a property tax appeal for previous tax years. The bill has an immediate effective date; however, many of the provisions do not take effect until taxable year 2024.

Here is an overview of the evolution of this bill:

- 11/8/23: <u>House Floor Amendment (HFA) 1</u> to SB 2315 was filed and referred to Rules Committee.
- 11/9/23: HFA 1 to SB 2315 was referred to Executive Committee.

HFA 1 to SB 2315 was heard in Executive Committee.

HFA 1 to SB 2315 was adopted, and the bill was debated on the House Floor. SB 2315 as amended passed out of the House with a <u>103-0-1 vote</u>.

SB 2315 as amended was sent to the Senate where it was placed on the Calendar Order of Concurrence-House Amendment(s) 1.

The Senate still needs to concur with the House's amendment and pass the bill as amended out of their chamber. Then, the Governor will need to sign the bill. A few steps remain before this bill can become a law, and the General Assembly will not reconvene until 1/16/24.
