

#### Introduction

As an Illinois veteran, you have earned benefits and services designed to support your education, career, and health care aspirations from the federal government and the state of Illinois. Each veteran has a unique background and situation qualifying him/her for a wide range of benefits.

The Illinois Department of Veterans Affairs (IDVA) is your vehicle for uncovering and obtaining the benefits and services that apply to you. With Veterans Service Officers across the state, we work with each veteran to discuss his/her personal, family, and health circumstances and identify which services and benefits will work for you.

## How is IDVA different from the United States Department of Veterans Affairs?

There is often confusion over the difference between the United States Department of Veterans Affairs (VA) and the Illinois Department of Veterans Affairs (IDVA).

- The IDVA is here as your local advocate to ensure you obtain your earned benefits at the federal and state level.
- While we don't dispense federal benefits, we help you identify and apply for these benefits. We also locate the Illinois benefits you have earned.
- We help you navigate both systems, so the process is less cumbersome and that you don't miss out on opportunities that are available to you.
- The IDVA also offers five veterans' homes across the state for those seeking residential care. The VA
  Healthcare System is ran by the federal government, but our Veterans Service Officers have resources to help you find the right place for you.

## **Compensation and Pension**

Veterans are eligible for various forms of federal and State of Illinois compensation and pension based on individual circumstances. Your local IDVA Veteran Service Officer will guide you through the process to identify and apply for benefits and services available to you.

## State of Illinois: Compensation

#### **Line of Duty Compensation**

Line of Duty Compensation is administered by the Illinois Court of Claims and provides approximately \$347,904 to the surviving next of kin of Illinois service members killed in the line of duty in support of the Global War on Terrorism.

### **Federal: Compensation**

#### **Combat Related Special Compensation**

Combat-Related Special Compensation is a tax-free payment to retired veterans with combat-related disabilities. You must apply for CRSC through the service branch from which you retired.

#### **Concurrent Retirement/Disability Payments (CRDP)**

Concurrent Retirement and Disability Pay (CRDP) allows military retirees to receive both military retired pay and Veterans Affairs (VA) compensation.

#### **Disability Compensation**

Disability compensation is a tax-free benefit paid to a veteran for disabilities that are a result of service-related injuries or diseases that occurred while on active duty, active-duty training, or inactive duty-training. Disability compensation is also paid to certain veterans whose disability is the result of treatment from VA health care.

#### Dependency and Indemnity Compensation (DIC) for Service-Connected Deaths

DIC monthly benefits are awarded to eligible survivors of a military service member whose death occurred while on active duty or whose death is connected to a service-related injury.

#### **Pensions**

#### **Veterans Pension**

Disability pension is paid to wartime veterans with disabilities with limited income or are age 65 and older.

#### **Survivors Pension**

The death pension is paid to eligible dependents of deceased veterans.

#### Aid and Attendance (A&A)

Aid and Attendance is a monthly benefit paid to an eligible veteran or surviving spouse requiring the support of an individual to perform daily functions, is bedridden, resides in a nursing home, or is blind.

#### Housebound

Housebound is paid to an eligible veteran with a permanent disability and is confined to his/her home.

#### Vietnam Veterans

The United States Department of Veterans Affairs has identified 14 illnesses connected directly to the Vietnam War and exposure to Agent Orange and other herbicides: Hodgkin's disease, multiple myeloma, respiratory cancers, non-Hodgkin's lymphoma, prostate cancer, acute and sub-acute peripheral neuropathy, type 2 diabetes, all chronic B cell leukemias, Parkinson's disease and ischemic heart disease. Compensation is awarded specific to the disease and severity.

#### **Gulf War Veterans**

Gulf War Veterans may receive compensation for chronic disabilities resulting from undiagnosed illnesses and medically unexplained chronic multi-symptom illnesses.

#### **Prisoners of War**

The trauma of being a prisoner of war transcends far beyond service. The United States Department of Veterans Affairs has identified consistent conditions that former POWs experience and compensation and awards based on individual circumstances.

#### **Atomic Veterans**

Veterans who participated in atomic tests and suffer from leukemia, cancer of the thyroid, breast, pharynx, esophagus, stomach, small intestine, pancreas, bile ducts, gall bladder, salivary gland, urinary tract, brain, bone, lung, colon, and ovary, bronchiole alveolar carcinoma, multiple myeloma, lymphomas, and primary liver cancer may qualify for this benefit.



## **Documentation**

#### Discharges, Service Records, and Medals

#### **Discharge Upgrades**

IDVA assists in applying for discharge upgrades and corrections.



#### **Bonuses**

The State of Illinois offers a one-time bonus for veterans who served honorably during a time of war. #### **World War II Bonus**

A bonus of \$10 per month for domestic service and \$15 per month for foreign service is payable for those who served on active duty between September 16, 1940, and September 3, 1945, and received an honorable discharge. Survivors are entitled to a benefit of \$900 if the veteran's death was service-connected, because of hostile action with unfriendly forces, and within the period specified above.

#### **Korean War Bonus**

A \$100 Korean War bonus is payable to veterans who served between June 27, 1950 and July 27, 1953 and received the Korean Service Medal.

#### **Vietnam War Bonus**

Veterans who received the Vietnam Service Medal or the Armed Forces Expeditionary Award are awarded a \$100 bonus. The veteran must haves served between January 1, 1961, and March 28, 1973, or served in Operation Frequent Wind, Vietnam, April 29 and 30, 1975.

#### **Persian Gulf War Bonus**

Veterans who received the Southwest Asia Service Medal and served between August 2, 1990, and November 30, 1995, are awarded a \$100 bonus. Individuals currently on active duty and meet this criterion must have their command complete an Armed Forces Certificate found on our web site. <a href="https://veterans.illinois.gov/services-benefits/benefits/compensation-benefits.html">https://veterans.illinois.gov/services-benefits/benefits/compensation-benefits.html</a>

#### **Global War on Terrorism**

Veterans who served on or after September 11, 2001, and received either the Global War on Terrorism expeditionary Medal, Global War on Terrorism Service Medal, Afghanistan Campaign Medal, or the Iraq Campaign Medal are eligible for a \$100 bonus. Eligibility includes serving at least 30 consecutive or 60 nonconsecutive days of foreign or sea service, residing in Illinois 12 months immediately prior to entering the service and discharged honorably. #### **Vietnam Survivors Compensation**

Vietnam Veteran survivors are entitled to a payment of \$1,000 if the veteran's death is service-connected due to conditions presumptive to exposure from herbicides as determined by the United States Department of Veterans Affairs.

#### **Global War on Terrorism Survivors Compensation**

Survivors of veterans who were killed by terrorist acts or hostile activities during military service on or after September 11, 2001, are entitled to compensation of \$3,000. Their service is terminated with a DD 1300 Report of Casualty. 12 months prior to entering the service.

#### **POW Compensation**

Persons on active duty with the Armed Forces of the United States or employed by the U.S. Government on or after January 1, 1961, and who were residents of Illinois 12 months prior to entry, and who were held prisoner by hostile forces in South East Asia are entitled to a \$50 bonus for each month held captive.

## **Education Benefits**

### Illinois Department of Veterans Affairs Education Programs

The Illinois Department of Veterans Affairs administers two education programs for dependent children of certain veterans: The Educational Opportunity Grant and the MIA-POW Scholarship.

#### **Educational Opportunity Grant**

The Educational Opportunity Grant of \$250 is provided annually to each child between the ages of 10 and 18 years of a veteran who either died on active duty, who's death is ruled service connected, is 100% totally and permanently disabled, or 100% disabled for at least two years. The Educational Opportunity Grant applies to a state educational institution, such as elementary school, middle or junior high school, high school, or vocational training school. Applicants must apply annually during the academic year to receive the grant.

### **MIA-POW Scholarship**

The State of Illinois provides an education scholarship to attend an Illinois public university or community college for the dependents of veterans who are either Missing-In-Action, a Prisoner of War, died while on active duty, s 100% totally and permanently disabled, or died because of a service-connected disabilities.

## Other State of Illinois Education Programs

#### The Illinois National Guard Grant

The Illinois National Guard Grant covers tuition and fees to attend an Illinois public university or community college for active members of the Illinois National Guard who meet program eligibility criteria.

#### The Illinois Veterans Grant

The Illinois Veterans Grant covers tuition and fees to attend an Illinois public university or community college for veterans who meet program eligibility criteria.

#### **Children of Veterans Tuition Waiver**

The Children of Veterans Tuition Waiver is a four-year consecutive instate tuition waiver at the University of Illinois given to natural, step, or legally adopted children of service members who are veterans.

#### **Federal Education Benefits**

Illinois Department of Veterans' Affairs Veterans Service Office are also to assist veterans, military service members and family members with applying for the following federal educational benefit programs.

#### Post 9/11 GI Bill (Chapter 33)

The Post-9/11 GI Bill (Chapter 33) helps pay for approved education and training programs. If you've served on active duty after September 10, 2001, you may qualify for the Post 9/11 GI Bill (Chapter 33).

#### **Transfer of Entitlement (Chapter 33)**

Military service members eligible for Chapter 33 may be able to transfer their Chapter 33 entitlement to their spouse or dependent children. The Department of Defense administers this program.

#### Fry Scholarship (Chapter 33)

If you are the child or surviving spouse of a service member who died in the line of duty after September 10, 2001, you may qualify for the Marine Gunnery Sergeant John David Fry Scholarship (Fry Scholarship).

#### Montgomery GI Bill (Chapter 30)

The Montgomery GI Bill (Chapter 30) helps honorably discharged veterans pay for approved education and training programs for those who have served on active duty for at least 2 years since June 30, 1985.

## Montgomery GI Bill - Selected Reserve (Chapter 1606)

The Montgomery GI Bill Selected Reserve (MGIB-SR) program offers up to 36 months of education and training benefits. If you are a member of the Army, Navy, Air Force, Marine Corps or Coast Guard Reserve, Army National Guard, or Air National Guard, you may be eligible for this benefit.

## **Survivors and Dependents Educational Assistance** (Chapter 35)

If you are the child or spouse of a veteran or service member who has died, is captured, or missing, the Veteran or service member is permanently and totally disabled due to a service-connected disability, you may be able to get help paying for school or job training through the DEA program—also called Chapter 35.

## **Employment Benefits**

## Vocational Rehabilitation and Employment (VR&E)

The VR&E program assists veterans who have service-connected disabilities obtain and maintain suitable employment. Independent living services are also available for severely disabled veterans who are not currently ready to seek employment. #### **Veterans Preference for Federal Jobs**

To receive preference, a veteran must have been discharged or released from active duty in the U.S. Armed Forces honorably. Preference is also provided for certain widows and widowers.

#### **Jobs for Vets**

The Illinois Department of Employment Security (IDES) provides a trained representative to help veterans receive training and job placement assistance. ## **Employment Assistance for Air National Guard**

State employees that serve in the Reserve Components receive 15 days of military leave per year and 60 days of special training.

#### **State Employment Preference**

Preference is given to honorably discharged veterans when applying for state employment with Central Management Services (CMS).

Illinois is home to nearly 50,000 women veterans. Nationally, the women veteran population is small in comparison to their male counterparts, however, studies show that by 2040 the women veteran population is expected to nearly double, making women the fastest growing veteran population.

## **United States Department of Veteran Affairs Benefits and Programs for Women Veterans**

#### **Center for Women Veterans**

VA's Center for Women Veterans monitors and coordinates VA's administration of benefit services and programs for women Veterans. The Center advocates for a cultural transformation that recognizes the service and contributions of women Veterans and women in the military, and also raises awareness of the responsibility to treat women Veterans with dignity and respect.

#### **VA Health Care for Women Veterans**

At each VA medical center nationwide, a Women Veterans Program Manager (WVPM) is designated to advise and advocate for women veterans. The WVPM can help coordinate all the services you may need, from primary care to specialized care for chronic conditions or reproductive health. Woman veterans who are interested in receiving care at VA should contact the nearest VA Medical Center and ask for the WVPM.

## What services does VA provide for Veterans who experienced MST?

VA offers free treatment for mental and physical health conditions related to MST and stands ready to support you in whatever way will help you best. This could include learning more about the effects of MST, treatment that helps you cope with how the experience of MST is impacting your life, or, for individuals who are ready, treatment that involves discussing your experiences in more depth. You may always ask for a provider of a specific gender if it would make you feel more comfortable. Note that you may be able to receive free MST-related care even if you are not eligible for other VA care.

MST-related services available through VA include:

- An MST Coordinator available at every VA health care system who can answer any questions you have about MST-related services and can help you find and access VA services and programs.
- Free MST-related mental health and medical care at every VA medical center and many VA community-based outpatient clinics.
- Free MST-related counseling at Vet Centers.
- Residential (live-in) or inpatient programs for more intensive mental health treatment and support. Some facilities have separate residential programs for women only. All residential programs have separate sleeping areas for men and women.

#### **Traumatic Brain Injury & Post Traumatic Stress Disorder**

Traumatic Brain Injury and Post Traumatic Stress Disorder have been called the signature wounds of the Iraqi and Afghanistan conflicts. PTSD has always been an issue, but it is more prevalent because of repeated tours of duty for many troops. The United States Department of Veterans Affairs at the federal and state levels is focusing on early detection intervention.

OIF/OEF veterans are encouraged to take advantage of the Veterans Administration Health Care System, which is offering five years of VA healthcare regardless of financial or health status. ## Burial Assistance, Plot/Internment Allowance

#### **Burial Assistance, Plot/Internment Allowance**

Certain benefits are available to assist with the burial expenses of deceased veterans.

#### **National Cemetery Burial**

Burial in a VA national cemetery is available at no cost to eligible veterans and their spouses and eligible dependents. For more information, visit their web site at <a href="https://www.cem.va.gov">www.cem.va.gov</a>

#### **Burial Flags**

A United States flag is provided, at no cost, to drape the casket or accompany the urn of a deceased veteran who served honorably in the U.S. Armed Forces to honor the memory of a veteran's military service to his or her country.

#### **Grave Marker or Headstone**

The U.S. Department of Veterans Affairs will furnish a headstone or marker, upon request, without charge for the unmarked grave of a veteran.

#### **Bereavement Counseling**

VA Vet Centers provide bereavement counseling to all family members of service members who died while on active duty.

#### **Cartage and Erection Fees**

#### **Grave Registration**

#### **Indigent Veterans**

The county Veterans Assistance Commission provides burial for any honorably discharged indigent veteran, or their mothers, fathers, spouse or surviving minor children without sufficient means of paying.

## **Housing Benefits**

#### **Home Loan Guaranty**

VA home loan guaranties are designed to help veterans, reservists, and unmarried surviving spouses obtain homes and refinance loans. In addition to periods of eligibility and conditions of service requirements, applicants must have a good credit rating, sufficient income, a certificate of eligibility and agree to live in the property. A VA guaranteed loan can be used to buy a home, build, repair, or improve a home (including energy efficient improvements), and refinance an existing loan. <a href="https://veterans.illinois.gov/services-benefits/survivor-burial/graves-registration.html">https://veterans.illinois.gov/services-benefits/survivor-burial/graves-registration.html</a>

#### **Specially Adapted Housing Tax Exemption**

This state exemption is allowed on the assessed value of real property for which federal funds have been used for the purchase or construction of specially adapted housing.

#### **Disabled Veterans Tax Exemption for Mobile Home**

This exemption applies to the tax imposed by the Mobile Home Local Services Tax Act when that property is owned and used exclusively by a disabled veteran, spouse, or unmarried surviving spouse as a home.

#### **Returning Veterans' Homestead Exemption (RVHE)**

A veteran may qualify for a \$5,000 reduction in the equalized assessed value (EAV) on his or her primary residence for two consecutive assessment (tax) years, the tax year, and the following year the veteran returns home from active duty.

#### **Disabled Veterans' Standard Homestead Exemption (DVSHE)**

The Disabled Veterans' Standard Homestead Exemption provides a reduction in a property's EAV to a qualifying property owned by a veteran with a service-connected disability.

#### **Specially Adapted Housing Grant**

Permanent and total disability is not required for the Specially Adapted Housing Grant. ## Fishing and Hunting Licenses

Free fishing and hunting licenses are issued for disabled veterans who are receiving 10 percent or greater service-connected compensation, or total disability pension benefits. The veteran may obtain this license from the IDVA by providing disability documentation that is no more than one year old. To acquire a permit, contact your local service office.



## **Transportation**

#### **Military Service Pass**

This Chicago Transit Authority pass is available to all active duty, Reserves and National Guard members as well as veterans who are 10 percent or more service-connected disabled.

CTA passes may be obtained by mail to Ventra Customer Service Center, 567 W. Lake St. 2nd Floor, Chicago, IL, 60661. Please take your Armed Forces I.D. or proof of compensation (dated within the last 12 months) if you are receiving disability pay of 10% or greater. #### **Veterans Conservation Corps**

The Veterans Conservation Corps is a joint program from the Illinois Department of Veterans Affairs and the Illinois Department of Natural Resources offering a wide range of volunteer opportunities. If you are interested in becoming a member of the Veterans Conservation Corps, contact an IDVA Veteran Service Officer.

#### **Veterans' Cash Grant**

Veterans' Cash funds are generated through purchase of an Illinois Lottery ticket and deposited into the Illinois Veterans Assistance Fund which supports non-profit organizations focused on veteran issues. Applications are reviewed by IDVA's Veterans Cash Grant Committee (VCGC). ### **Incarcerated Veterans Program**

The Incarcerated Veterans Transition Program (IVTP), is a multi- agency initiative operated by the Illinois Departments of Corrections, Veterans' Affairs and Employment Security, and aimed at cutting down the recidivism rate among veterans.

## **Disabled Veterans License Plates and Parking**

Disabled Veteran License Plates may be issued at no cost for the first set of plates to any U.S. Armed Forces Veteran if the veteran holds proof of a service-connected disability from the United States Department of Veterans Affairs and a licensed physician has certified that because of the service-connected disability, the veteran qualifies for the issuance of a disabled placard or plate.
